Understanding the Challenge

ISEA, Integrity Solutions, Engineering, and Analytics, was established in 2023 to provide cybersecurity and IT engineering support to government clients in the Intelligence Community (IC) and Department of Defense (DoD). When ISEA started, it was a small but visionary two-person team. They knew that working in government spaces meant meeting strict cybersecurity and compliance requirements. Instead of waiting for mandates to catch up with them, they wanted to get a head start on building an compliant IT infrastructure that could grow alongside their business.
